Scope

How We Use Your Data

- Diagnose system issues, optimize user experience, and develop new features.
- Send account notices, performance summaries, and respond to inquiries.
- Prevent fraud, enforce Terms of Service, and comply with legal obligations.

Legal Basis & Consent

- Required for sensitive data or communications; users may withdraw consent at any time.
- Processing core account data to deliver requested services.

Data Minimization & Retention

- We collect only data essential to provide and improve Kaabil.

Retention Periods

- Active Accounts: Data retained while the account remains active.
- Closed/Inactive Accounts: Personal data archived up to 12 months post-closure, then deleted or anonymized.
- Usage Logs: Retained for 6 months.

Security Measures

- Role-based permissions; multi-factor authentication for administrative access.
- Quarterly vulnerability scans and annual security assessments.

Sharing & Disclosure

- No Sale of Personal Data: We never sell or rent personal information.
- Service Providers: Share minimal data under strict confidentiality agreements (e.g., cloud hosting, analytics).
- Educational Institutions: Provide only aggregated, anonymized class-level insights to schools.
- Legal Requirements: Disclose data if mandated by law or to protect legal rights and safety.

Your Rights & Controls

- Obtain a copy of your personal data in machine-readable format.
- Correct inaccurate or incomplete data.
- Request deletion of your data.
- Limit processing or object to certain uses (e.g., marketing).
- Withdraw Consent for sensitive data and cookies.
